Course Specific Information

Master of Prosthetics and Orthotics:

The **Master of Prosthetics and Orthotics (M.P.O)** course is a postgraduate degree course under the category of Allied Healthcare. This PG course focuses on the specialized profession of **Prosthetics & Orthotics** which involves designing, fabricating and fitting Prostheses (Artificial Limbs) and Orthoses (Supportive Devices and Splints) and Mobility Aids and Assistive Devices for individuals with locomotor disabilities.

This course features subjects like Advances in Lower Extremity Prosthetics, Advances in Lower Extremity Orthotics, Advances in Upper Extremity Prosthetics, Advances in Spinal Orthotics, Mechatronics, Pedagogy in Prosthetics and Orthotics

Duration of the Course: Two Years

Affiliation of the Course: The course is affiliated to the Maharashtra University of Health Sciences, Nashik.

Recognition of the Course: The course is approved and recognized by the Rehabilitation Council of India (RCI) which is a statutory body established by an Act of Parliament in 1992.

Language of Study: English

1. Number of seats available: Total 04 seats

1.1 Two (2) seats are for candidates who have passed Bachelor's Degree in Prosthetics & Orthotics from Colleges/Institute from anywhere in India, including Maharashtra (All India Quota). Selection of candidates under All India Quota will be done as per merit, according to the result of Entrance Test conducted by this Institute for the academic year 2025-26. (Applicants who have passed their B.P.O. course from MUHS, Nashik / Maharashtra are also eligible to apply under this quota.) Reservation of roster as per Government of India guidelines will be maintained.

1.2 Two (2) seats are for candidates who have passed Bachelor's Degree in Prosthetics & Orthotics from Maharashtra State only (Maharashtra State Quota). Selection of candidates for under Maharashtra State Quota will be done through the Common Entrance Test conducted by Directorate of Medical Education and Research, Mumbai, Maharashtra, i.e. P.G.-P & O - CET. 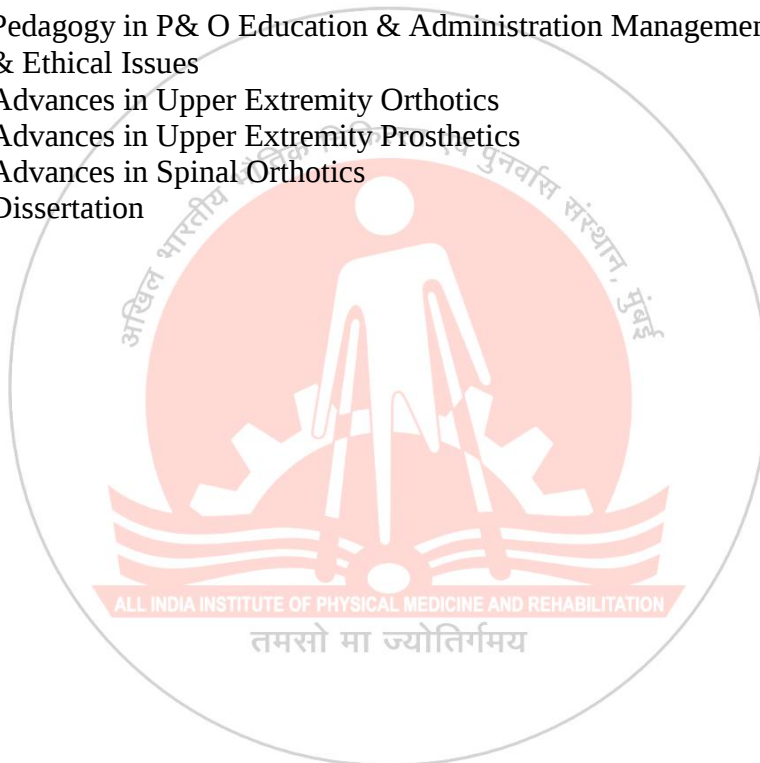

3. Admission Procedure:

3.1. Who can apply?

Eligibility:-

- 3.2 Bachelor's degree in Prosthetics and Orthotics (P&O) from an institute recognized by Rehabilitation Council of India with completion of compulsory six months Internship.
- 3.3 Date of Completion of Internship: on or before **30/09/2025**
- 3.4 Candidate must appear for the entrance test conducted by this Institute for the academic year 2025-26. Seats will be allotted as per merit, according to the result of Entrance Test.
- 3.5 The candidate must be an Indian National.
- 3.6 Registration of the candidates with RCI is mandatory as per MUHS guidelines.
- 3.7 Students who have passed Bachelor's degree in Prosthetics and Orthotics from Agricultural University or Distance Education Mode are not eligible for admission to this course as per MUHS Circular No.8/2017 & Outward No. MUHS/C-5/PG. Allied/1280/2017 dated 16.8.2017.
- 3.8 Eligibility of the candidates admitted, is granted by Maharashtra University of Health Sciences, Nashik and Institute takes no responsibility for the same. It is not assured by the Institute at the time of admission that University will grant eligibility to the candidate.

4. How to Apply:

- 4.1 The students can download the **Prospectus and application form** from the Institute's website www.aiipmr.gov.in and duly filled in application is to be sent to the institute along with Application fee*.
- 4.2 Please write (applicant's) name and course name on the backside of the Demand Draft / Pay Order along with mobile no. of the candidate.

5. Reservation:

- 5.1 Reservations will be done as per prevailing provisions at Government of India Institutes and as amended from time to time.
- 5.2 OBC reservation will be made as per "Central List of OBC."
- 5.3 Eligibility of the applicants with disabilities will be decided by Medical Board of the Institute constituted for the purpose.



6. APPLICATION FEE:

- 6.1 Application fee for General category candidates is Rs. 800/-
- 6.2 Application fee for **SC/ST/PH** candidates is Rs. 600/-
- 6.3 All Payments will be accepted in the form of Demand Draft/ Pay Order drawn in favor of '**Director, AIIPMR**' Payable at **Mumbai** from any nationalized bank only.
Payment in any other form will be rejected.
- 6.4 The Application fee is non- refundable and non- transferable under any circumstances.

7. SUBMISSION OF APPLICATION FORM:

- 7.1 Duly filled application form along with admit card for MPO course only (in duplicate), Application Fees and required self-attested certificates as mentioned in the application form can be submitted in **Room No. 201**, 2nd floor / can be sent by post on Institute's address so as to reach on or before **12/09/2025** for MPO.
Applicants are advised to regularly check the institute website for any addendum / Corrigendum related to the admission process.
- 7.2 Incomplete applications or application received after last date of submission will be rejected and no fees will be refunded/ returned under any circumstances and no communication in this regard will be entertained.
- 7.3 Photographs on the application form and on the admit card should be same, clear and taken within the last six months.
- 7.4 In case of personal submission, if an applicant requires acknowledgment of submission of application form he /she should bring a photocopy of the filled in application form on which acknowledgement will be provided.
- 7.5 All correspondence will be done on the correspondence address furnished by the applicant in his/ her application form.

Application fee received after due date will not be refunded.

8.2 All payments should be made in the form of Demand Draft/ Pay Order drawn in favor of 'Director AIIPMR' payable at Mumbai.

Payments in any other form will not be accepted.

All applicants are requested to write their name and course name on the back side of the D.D. along with the mobile no. of the candidate.

8.3 After admission students can apply for scholarship through **MAHADBT** portal, **NSP**, **DMER**, and **PM Vidyalaxmi** etc. as applicable.



8.4 100% of the fees mentioned in point no. 8.1 (i.e. Rs.13900/-) are to be paid at the time of admission. (Cut-off date will be declared by University / D.M.E.R., Govt. of Maharashtra).

8.5 All students are required to apply for refund of deposits along with the Original Fee receipt, immediately after the completion of course, else the Amount of refundable Deposits will be forfeited.

8.6 No stipend will be paid to the admitted candidate.

9.4 Entrance Test pattern: Entrance Test will be of one hour duration of 60 marks consisting of Multiple Choice Questions based on syllabus taught at Under Graduate Level i.e. Bachelor of Prosthetics & Orthotics standardized by Rehabilitation Council of India

9.5 Each Question will have 4 choices (A), (B), (C) and (D) out of which one is correct. Candidates have to write the correct answer in the given box against the question. Candidates should not use any other method for answering (Use blue/ black point ink only).

10. ADMIT CARD OF ENTRANCE TEST:

10.1 Admit Card will be sent by post to applicants which will be received approximately 10 days prior to the date of Entrance Test. Candidates are supposed to attach a self-addressed envelope of size 23cms. x 11.5cms affixing postage stamp of `60/- superscripted 'Admit card for (Name of the course)' and should be enclosed along with the application form.

10.2 In case of delay or non-receipt of Admit Card, candidate can collect the Duplicate Admit Card from the examination center on the day of the Entrance Test on producing photocopy of Demand Draft.

- 11.5** Mobile phone, calculators and any electronic devices will not be permitted in Exam Hall.
- 11.6** Calculations/ rough work can be done on a separate paper provided with the main booklet.
- 11.7** Overwriting or changing an answer is not permitted. The Candidates must fully satisfy themselves about the correctness of the answer before writing the alphabet in the blank box.
- 11.8** No change in the answers once written is permitted and the same will be treated as invalid / incorrect response and no marks will be awarded for the same.
- 11.9** Each question carries equal marks. There will be no negative marking.



- 11.10** Without Admit Card candidate will not be allowed to enter in the Examination Hall.
- 11.11** It is mandatory to carry one original photo identity proof along with the admit card on the day of examination.
- 11.12** Result of Entrance Test will be published later on the Institute's notice board and Website.
- 11.13** Declaration of selected candidates for M.P.O. courses (according to the result of Entrance Test): information will be uploaded Institute website- www.aiipmr.gov.in
- 11.14** Selection of candidates will be Provisional, and final eligibility will be granted by the Maharashtra of Health Science, Nashik University.
- 11.15** All Candidates are hereby instructed to keep on checking the Institute's website/ Notice board for details regarding merit list/ selection list/ waiting list/ any instructions/ updates which will be posted periodically.
- 11.16** There will be no rechecking /re-evaluation for the Entrance Test answer sheets. However candidate can apply for verification of marks by giving an application on plain paper within four days of declaration of Entrance Test results along with Application fee of Rs.500/- in the form of Demand Draft to be drawn in favour of 'Director, AIIPMR' Payable at Mumbai.
- 11.17** Candidates have to appear for the Entrance Test at their own expenses and make arrangement for their accommodation in Mumbai on their own.
- 11.18** No accompanying person will be allowed at any cost inside the examination venue.

12.2 Selection of candidates will be provisional, and final eligibility will be granted by the Maharashtra University of Health Sciences, Nashik.

13.15 The candidates belonging to Reserved (SC/ST/OBC/PH) categories who have claimed so in his/her application form, should submit self- attested / certified copies of the relevant certificates caste certificate/ caste validity certificate/ OBC (valid Non-Creamy layer certificate valid up to **31/03/2026**) / disability certificate] applicable, along with the original of the same, issued by competent authority at the time of admission compulsorily.

(Those candidates who have applied for the applicable certificates should produce the proof of the application in original and should declare that if the certificates is not made available before submission of enrollment and eligibility form to the University, the admission may be treated as cancelled)

Note- In case a caste Validity Certificate is not issued by a particular state they should obtain a Certificate Issued by competent authority - As per annexure-II

Note: Candidates are instructed to obtain the necessary certificates well in advance as they are mandatory & have to be submitted in original at the time of seeking admission. There may not be any relaxation for submission of the same at the time of admission.



14. Cancellation of admission for MPO course:

- 14.1** If a candidate cancels his/ her admission before the cut –off date (D.M.E.R., Government of Maharashtra, State CET Cell) the security deposit of Rs.1500/-(Rupees one thousand five hundred only) will be forfeited as administration charges & rest of the fees will be refunded.
- 14.2** No refund of fees including deposits will be given if a candidate cancels his/her admission after the cut-off date i.e. admitted under All India Quota as well as under Maharashtra State Quota (Selected by DMER).
- 14.3** Admission will be cancelled on production of ‘No-Dues’ Certificate from the Librarian/ Head of the Department along with application.
- 14.4** All students are required to apply in prescribed format for refundable deposits immediately after final examination / completion of the course, in order to get the refund.
- 14.5** Cut-off date for admission will be declared by D.M.E.R./State CET Cell, Government of Maharashtra.

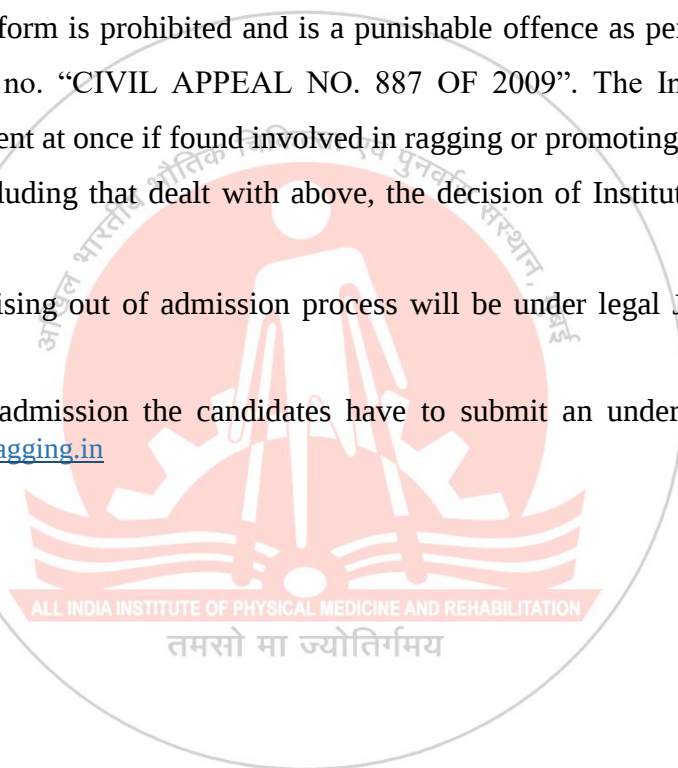
15. Hostel:

The Institute has limited hostel facilities. Allotment of hostel accommodation is made by the Hostel Committee, as per laid down criteria by the Institute authority. Students are at liberty to make their own stay arrangements as the Institute authorities don't insist on compulsory hostel stay.



16. Conduct & Discipline:

- 16.1** Providing false information, making incorrect statements in the application form and/or suppression of any information may lead to disqualification of the candidate for the course & may render immediate debarment, at any given point of time.
- 16.2** Adopting any unfair means or engaging in malpractice in the examination hall is strictly prohibited.
- 16.3** Ragging in any form is prohibited and is a punishable offence as per Honorable Supreme Court directives no. “CIVIL APPEAL NO. 887 OF 2009”. The Institute authority will rusticate the student at once if found involved in ragging or promoting ragging.
- 16.4** In any issue including that dealt with above, the decision of Institute Authorities will be final.
- 16.5** Any disputes arising out of admission process will be under legal Jurisdiction of Mumbai High Court only.
- 16.6** At the time of admission the candidates have to submit an undertaking on UGC web portal–www.antiragging.in
