Institute has planned Re-development & Re-construction of Workshop Building with an Academic Block on Plot 10A on EPC basis. SFC approved ₹.21.55 crores for the above project for Gr.+4 storey structure vide Ministry's letter No.G.25011/4/2008-MH(Pt.)/PH-II dated 28.07.2010. Due to different reasons the construction work has not started.

IOD for FSI of 1.33 with height restriction of 18.30 mtrs has been received on 30.07.2014 (2 B + Gr.+2 floors) and additional FSI of 0.46 has been received (total FSI 1.79).

The project cost has increased from ₹.21.55 crores to ₹.46.03 crores due to change in scope. Height restrictions for all the building (in the areas around the Nehru Centre Funnel) has been removed from DCPR 2034 by the concerned authorities. Hence, it is permissible to construct the structure upto 45 mtrs i.e. 2B + Gr. + 10 floors. Keeping in view the present shortage of space and future space requirements this Institute is planning to utilize the permission and construct 2B + Gr. + 10 storey structure for which PMC meeting is planned.


